The first half of the training is a 4.25- hour live session. The second half of the course is a 3.75-hour computer-based study. An examination on the computer study must be successfully completed within 30 days of the live training session as part of the process to obtain a waiver for prescribing buprenorphine. Instructions on how to log on to the second half of the course will be provided via email ONLY to those who complete the live session in its entirety. Please note that in order to be eligible for the waiver to prescribe Buprenorphine, you must complete a total of 8 hours consisting of the live session (4.25 hours) and the online self-study session and exam (3.75 hours - within 30 days of the live training). The AOAAM cannot verify completion of the live session if less than 4.25 hours are attended.
