Video Visit Enhancements, Digital Proxy Access and MyHealth Inpatient Milestone


We're excited to inform you about new features added to our Video Visit capability and highlight our digital proxy access and the launch of MyHealth Inpatient at ValleyCare.

1. Video Visits: Multiparty conferencing and screenshare functionalities



Multiple care team members (1 billing provider and up to 3 additional care team members) can simultaneously join in on ambulatory Video Visit encounters. All care team members joining should navigate to the same shared encounter to launch the video visits. Please view the [KB article](#) for more information. In addition, care team members also have the ability to share screens with patients during the Video Visit if needed.

2. Share health information with families and caregivers digitally



Adult patients (18-years or older) can digitally share their health information with another adult individual (18 years or older) such as a family member or caregiver. Both parties have to be registered MyHealth users, but MyHealth now makes sending an invite to Share Access with one's medical information a simple button push from within either the mobile app or web interface. 3. MyHealth Hospital View reached major milestone with February 2020 ValleyCare launch

In late February, we reached a major milestone when MyHealth Inpatient went live at Stanford Health Care – ValleyCare. Patients can share access with other caregivers, gain visibility into their test results, care team members, medications, health education, pain/mobility goals, and discharge readiness information. With this launch, all patients within the Stanford hospital network all have access to a differentiated and more transparent digital inpatient experience.
